In exercise of the power conferred under section 19(3) of the Motor Vehicles and Road Traffic Act, Cap. 8.01, the Minister responsible for transport makes this Order:

### Citation

**1.** This Order may be cited as the Motor Vehicles and Road Traffic (Licence Number) Order, 2013.

## Interpretation

**2.** In this Order, 'the Act' means the Motor Vehicles and Road Traffic Act, Cap.8.01.

#### Amendment of section 19

3. Section 19(2) of the Act is amended –

- (i) in paragraph (h), by deleting the full stop after the word 'taxi' and substituting a semi-colon; and
- (ii) by inserting immediately after paragraph (h) the following paragraphs -
  - '(i) use for hiring for rental purposes, to carry a maximum of twelve passengers;
  - (j) use for farming activities.'.

In exercise of the power conferred under section 10(2) of the Value Added Tax Act, No. 7 of 2012, the Minister responsible for finance makes this Order:

### Citation

**1.** This Order may be cited as the Value Added Tax (Rate of Tax) (Goods and Services – Hotels and other providers in the tourism sector) Order, 2013.

#### **Commencement and duration**

**2.** This Order is deemed to have come into force on the 1<sup>st</sup> day of May, 2013 and terminates on the 31<sup>st</sup> day of March, 2014.

# Rate of tax

**3.** The rate of tax for the following goods and services provided by hotels and other providers in the tourism sector is eight percent:

- (a) a supply of accommodation services by a hotel; and
- (b) a supply of food and beverages, including alcoholic beverages, by a restaurant.

## **Affirmative Resolution**

**4.** This Order is subject to an affirmative resolution in Parliament.
